### **MICHAEL ALFANO, DMD, PHD**

Dr. Michael Alfano is a successful researcher, educator and business person recognized for insightful thinking, and for innovative approaches to education and improving communications among the academic, government and business sectors. Dr. Alfano received his DMD from the University of Medicine and Dentistry of New Jersey and a PhD in Nutritional Biochemistry & Oral Biology from the Massachusetts Institute of Technology, Department of Nutrition & Food Science.

After retiring from New York University in 2014, he continued to serve as a member of the Boards of DentsplySirona, Inc. and the Santa Fe Group. Dr. Alfano also consults on finance, budget and clinical operations for educational institutions and non-profits. Recent awards include the Tribute Award from Oral Health America (2016) and the Achievement Medal (2016) from Alpha Omega International. He was a founder of the Friends of NIDCR, Nexus Magazine, and the Santa Fe Group. Dr. Alfano currently assists the Santa Fe Group and several other associations and consumer advocacy organizations to create a dental benefit within Medicare.

### **MYRON ALLUKIAN, JR., DDS, MPH**

Dr. Myron Allukian Jr. formerly served as the Dental Director for the City of Boston for 34 years, and is a Past President of the American Public Health Association (APHA), the 1st Vietnam Veteran and 2nd dentist at that time in APHAs history. Dr. Allukian Jr. is board certified in dental public health and a Past President of the American Association of Public Health Dentistry, American Association for Community Dental Programs, and the American Board of Dental Public Health. He has over 150 publications/abstracts and 23 book chapters.

While with the 3rd Marine Division in Vietnam, he set up a "people to people" program in the orphanages, refugee camps and villages in the Danang area. Dr. Allukian Jr. was the first dentist to receive the Sedgwick Medal for Distinguished Service in Public Health. Dr. Allukian is currently Vice Chair of the Oral Health Working Group, World Federation of Public Health Associations; Vice President of the American Fluoridation Society; and President of the Massachusetts Coalition For Oral Health. He holds a BS from Tufts University, DDS from the University of Pennsylvania, and MPH from the Harvard School of Public Health. He is on the dental faculties of Harvard, Tufts and Boston Universities.

### **LEON ASSAEL, DMD**

Dr. Leon Assael is Professor and founding Dean of the California Northstate University College of Dental Medicine. He is adjunct Professor of Preventive and Restorative Dentistry in community health at University of California San Francisco. Previously he served as Dean of the University of Minnesota from 2012-2017 which has the first US dental school-based dental therapy program.

A graduate of Columbia University, Dr. Assael earned his doctor of dental medicine from Harvard University School of Dental Medicine. He holds a certificate in medical management from the Gatton School of Business, University of Kentucky. He completed his residency in oral and maxillofacial surgery at Vanderbilt University. Dr. Assael serves on many professional organizations including the American Dental Association and the Hispanic Dental Association. The American Association of Oral and Maxillofacial Surgeons awarded Dr. Assael and the Board of Trustees a special recognition award in 2010. He is the recipient of the national Gies award for vision from the American Dental Education Association (ADEA) and is the past chair of the ADEA Board of Directors.

### **VICTOR BADNER, DMD, MPH**

Dr. Victor Badner is a graduate of University of Pennsylvania and Harvard School of Dental Medicine (DMD) and UCLA (MPH). He completed a General Practice residency at Montefiore Medical Center in NY and a Dental Public Health (DPH) residency at University of California San Francisco, and became board certified in Dental Public Health. Currently, he is Department Chairman of Dentistry/Oral and Maxillofacial Surgery at Jacobi Medical Center and North Central Bronx Hospital. He serves as Co-Chair of the Council of Dental Chairmen of NYC's municipal hospitals. He has served as President of the Medical Board at Jacobi Medical Center.

Dr. Badner published and received grants for promoting inter-professional education, residency training, assessing and improving oral health services to HIV infected patients and underserved populations. In 2013, he was the author of a book chapter, *Oral Complications of Pregnancy*, in *Cherry and Merkatz's Complications of Pregnancy* and another chapter in 2019 on *Dental Financing* in the textbook *Dentistry, Dental Practice, and the Community*.

### **JAY BALZER, DMD, MPH**

Dr. Balzer obtained the DMD degree at the University of Connecticut School of Dental Medicine, the MPH degree from the University of Michigan School of Public Health and completed a Residency in Dental Public Health at the University of Florida College of Dentistry. He is a Diplomate of the American Board of Dental Public Health. He spent a 20-year career as a Commissioned Officer of the U.S. Public Health Service in multiple assignments, including the Indian Health Service, the National Health Service Corps, a State Maternal and Child Health Program, and administering federal health programs in a USPHS Regional Office.

Upon leaving Federal service, Dr Balzer became Executive Director of a non-profit community dental clinic and later, Program Director of the Dental Public Health Residency at NYU Langone Health. These varied career experiences have given Dr Balzer an appreciation for the unmet oral health needs of vulnerable populations and the potential to at least partially meet these needs through the wider use of dental therapists.

### **TERRY BATLINER, DDS, MBA**

Over 37 years, Dr. Terry Batliner has worked in many roles - dental entrepreneur, scientific investigator, health care management professor, dental insurance executive, senior level administrator in the VA and Indian Health Service, dental school associate dean and private practice dentist. For more than ten years, he has been an active advocate for the expansion of services to people living in native communities, inner cities and rural areas through the use of dental therapists. Currently Dr. Batliner is director of the Batliner Group – a healthcare consulting firm located in Colorado.

### **KENNETH BOLIN, DDS, MPH**

Dr. Kenneth Bolin is the Medical Director of the Sammons Cancer Center Dental Clinic at Baylor Scott and White Health in Dallas, Texas and is a faculty member for the Iĭisaĭvik College Alaska Dental Therapy Education Program in Anchorage, Alaska. He graduated from the University of Texas Health Science Center in San Antonio with a DDS degree and completed a fellowship program in Dental Oncology at the University of Texas MD Anderson Cancer Center. Following his fellowship, he obtained his Master of Public Health degree from the UT School of Public Health-Houston and received his certificate in Dental Public Health from TAMU Baylor College of Dentistry. Dr. Bolin is also board certified by the American Board of Dental Public Health.

### **THOMAS BORNSTEIN, DDS**

Dr. Thomas Bornstein is the former Director of Dental Services for the Southeast Alaska Regional Health Consortium (SEARHC), a position he held for 30 years. SEARHC is a tribal health organization responsible for providing medical and dental services throughout southeast Alaska. The dental program delivered a full range of services including: primary care provided by Dental Health Aides; dentists, dental therapists (DHATs), hygienists, and dental residents and specialty care provided by pedodontists, orthodontists, prosthodontists and endodontists. SEARHC provides dental care in diverse settings such as hospital operating rooms, large outpatient clinics and remote rural village clinics. Dr. Bornstein now teaches part-time in the Dental Health Aide Therapist (DHAT) training program in Bethel, Alaska.

Dr. Bornstein retired from the US Public Health Service at the rank of Captain. He received his dental degree from the University of Maryland Dental School and completed a two-year general practice residency (AGPR) through the US Public Health Service. Additionally, he holds a BA degree (Sociology) from Tulane University, a BS degree (Zoology) from the University of Maryland, and a BA degree (Art) from the University of Alaska.

### **LARRY BURNETT, DDS**

Dr. Larry Burnett received his dental degree from the Medical College of Virginia, which is now known as Old Dominion University. After graduation, he practiced in the states of Virginia and Florida. He was Supervising Dentist and Adjunct Professor of Oral Microbiology at the School of Dental Hygiene, Northern Virginia Community College Annandale, Virginia. Dr. Burnett became a noted lecturer and authority on the subject of periodontal therapy and caries prevention.

Dr. Burnett has traveled throughout the United States and Canada making presentations at the Academy of General Dentistry Annual Scientific Sessions, the American Dental Association Annual Scientific Sessions and the American Dental Hygienists' Association Annual Session. His extensive experience led him to become a co-designer of one of the most widely used ultrasonic instruments, the Burnett Power Tip (named after Dr. Burnett) used to treat periodontal disease. He has authored numerous articles on non-surgical treatment of periodontal disease, biofilms and caries prevention.

### **TAMMY GIERKE BUTTON, DDS, MSD, MA**

Dr. Tammy Gierke Button has a broad background in clinical pediatric dentistry and has a record of accomplishment leading dental offices and clinics. She also has served as Executive Director of Southshore Skipping Stones Dental Education Foundation, for the past five years. The Foundation delivers prenatal and early infant dental health education classes in both English and Spanish specific to addressing oral health inequities in Northern Indiana. She has a long history of advocacy and action regarding access to care, social justice, and oral health equity for underserved populations. As a clinician, she has provided pediatric dental care to underserved populations in various locations around the United States and has supervised dental students and residents in pediatric dentistry. She is also currently serving as a consultant for Indiana University School of Dentistry Community Based Dental Education Program. Dr. Button is a graduate of Indiana University School of Dentistry and received specialty training in pediatric dentistry at Riley Hospital for Children in Indianapolis, Indiana.

### **DAVID CAPPELLI, DMD, MPH, PHD**

Dr. David Cappelli is the Professor and Chair of the Department of Biomedical Sciences at the University of Nevada. Dr. Cappelli earned his DMD and MPH from the University of Pittsburgh, and his PhD in epidemiology from the University of Texas Health Science Center-Houston, School of Public Health. He completed his residency education in dental public health from the University of Texas Health Science Center at San Antonio (UTHSCSA), Department of Community Dentistry, and was awarded Diplomate status by the American Board of Dental Public Health.

Dr. Cappelli developed an extensive career in research, education, and service. During 2015, Dr. Cappelli received two awards from the Health Resources and Services Administration (HRSA) totaling \$3.75 million. Through the grants, he established the American Institute for Dental Public Health where he serves as the executive director. The awards created educational opportunities for dental public health residents across the country and expanded the dental public health workforce. Dr. Cappelli has held leadership positions in several national and state organizations, including past-president of the American Association of Public Health Dentistry (AAPHD), and is currently chair of the AAPHD Foundation Board.

### **FRANK CATALANOTTO, DMD**

Dr. Frank Catalanotto is a graduate of the College of Medicine and Dentistry of New Jersey and completed a post-doctoral research fellowship in pediatric dentistry at Harvard School of Dental Medicine and Children's Hospital Medical Center in Boston. During his long career in dental education and research he has been on the faculty of five dental schools. Dr. Catalanotto is the co-author of more than 110 scientific publications and has been the principal investigator or co-investigator for numerous federal, state and foundation grants.

Dr. Catalanotto has been active in dental education, research and advocacy organizations for much of his career. He served on the American Dental Education Association Board of Directors as vice-president for Deans and as President of ADEA from 2002-03, representing all of dental education. Many of the other organizations he has served on have a focus on improving access to care for all. His academic and professional interests include community-based dental education, ethics/social responsibility, oral health disparities and racial equity, advocacy for health care reform and access to dental care. In addition to the above topics, Dr. Catalanotto's current advocacy efforts are focused on the new emerging oral workforce models.

Dr. Frank Catalanotto is the former dean and currently a professor in the department of community dentistry and behavioral science at the University Of Florida College Of Dentistry. ### **JAMES C. CECIL, III, DMD, MPH**

Dr. Jim Cecil, CAPT, DC, USN (Ret), is a graduate of the University of Kentucky, College of Dentistry, the University of Michigan, School of Public Health, and Bellarmine College in Louisville, KY. Dr. Cecil served in various positions in the United States Navy as clinician, leader, administrator, assistant inspector general, and research investigator and research program administrator. His last assignment was as the Adviser to the Assistant Secretary of Defense (Health Affairs). Following Navy retirement, he was appointed to the Faculties of the UK College of Dentistry and the College of Public Health. He served as Dental Director for the Commonwealth of Kentucky 2001-2007.

He is a Fellow of the International College of Dentists, and the American College of Dentists, a member of Omicron Kappa Upsilon, a member of the Pierre Fauchard Academy, member of the Honorable Order of Kentucky Colonels, and received the John W. Knutson Award. Dr. Cecil was inducted into the University of Kentucky Public Health Hall of Fame in 2011. Dr. Cecil's research and public service interests included the epidemiology and prevention of oral diseases and conditions, the linkages of oral infections with systemic

diseases, access to oral healthcare and prevention, the assurance of sound health and safety for those most at risk.

### **ROBERT COLLINS, DMD, MPH**

Dr. Robert Collins joined the faculty at the University Of Pennsylvania School Of Dental Medicine in 2006 after careers in the US Public Health Service and with the International Association for Dental Research. He served as the Director of the Division of Community Oral health from 2006-2012. He continued to serve as the Director of the Office of International Relations and as Head of the WHO Oral Health Collaborating Center until 2015.

Dr. Collins continues to lecture and conduct seminars related to public health. He mentors University of Pennsylvania Dental Medicine students enrolled in the DMD-MPH dual-degree program, as well as those who may have interest in exploring whether dentistry in public health settings may be part of their future professional careers.

### **RAYMOND DAILEY, DDS**

Dr. Raymond Dailey is the Clinical Dentist of the Swinomish Clinic where he helps lead the effort to address the oral health crisis in Indian County. He is currently supervising two dental therapists through their preceptorships and works alongside Mr. Kennedy, a dental therapist with 10 years' experience. Dr. Dailey is an advocate for a well-rounded dental team utilizing dental therapists and expanding the functions of dental assistants, as well as recognizing the importance of culturally competent care and diversifying the dental profession.

Dr. Dailey completed his dental education at the University of North Carolina. After graduation, he returned to the Pacific Northwest and worked with the Klamath Tribal Community in Oregon for two years before taking a job with the Swinomish Tribal Community, where he has provided dental care for more than 20 years. During his time with the Swinomish Dental Clinic, Dr. Dailey has seen it grow from 4 chairs to 14. He was one of the first dentists in Washington to testify for dental therapists in Olympia. Dr. Dailey continues to volunteer his time providing free dental care to migrant farm workers with the Dental Van sponsored by Sea-Mar.

### **MARK DAVIS, DDS**

Dr. Mark Davis is an Adjunct Clinical Associate Professor at the University Of Florida College Of Dentistry. He has also held the position of Staff Dentist at the Lake City VA Medical Center and the Miami VA Medical Center, had a private practice in Houston, Texas and was a Captain in the US Army Dental Corp.

### **MIRANDA DAVIS, DDS, MPH**

Dr. Miranda Davis is the Native Dental Therapy Initiative Project Director with the Northwest Portland Area Indian Health Board. In this role, Dr. Davis assists tribes in Oregon, Washington, and Idaho as they incorporate dental therapists into their clinics. Dr. Davis also provides clinical care with the Puyallup Tribe in Washington State, where she has worked since 2006.

Dr. Davis is passionate about public health, disease prevention, and expanding access to high quality oral health care. She has special interest in helping patients with dental fears and in providing respectful care. Originally from northern California, Dr. Davis received a DDS from University of the Pacific in San Francisco and an MPH from University of Washington.

### **JACK DILLENBERG, DDS, MPH**



Dr. Jack Dillenberg is Dean Emeritus of A.T. Still University's Arizona School of Dentistry & Oral Health (ASDOH) after serving fifteen years as the Inaugural Dean. After dental school he served as a Dentist in the US Navy then practiced at a residential facility for people with severe disabilities before moving to Jamaica to work in a very rural clinic for their Ministry of Health.

Prior to joining ASDOH, Dr. Dillenberg was Associate Director for public health programs in the California Department of Health Services and prior to that served as an Area Health Officer serving the west area of the Los Angeles County Department of Health Services. During most of the 1990s, Dr. Dillenberg served in several capacities in the Arizona Department of Health Services, including four years as its Director.

Dr. Dillenberg is the recipient of a great number of honors and awards, including the Arizona Medical Association Humanitarian of the Year, the Fresh Start Foundation Man of the Year, the Harvard School of Public Health Alumni Award of Merit and the Lifetime Achievement Award from the American Academy of Developmental Medicine and Dentistry. Most recently, the American Association of Public Health Dentistry 2019 Distinguished Service Award.

He currently is the executive clinical director for the newly created non-profit Pacific Dental Services Special Needs Dental Clinic in Phoenix, AZ. Dr. Dillenberg serves as the Board President of Global Smiles For All a 501c3 nonprofit making a difference in global oral health. He also serves as the Global Ambassador for the American Academy of Developmental Medicine and Dentistry, and currently is the Board Chairman for the Brighterway Institute. He was recently elected to the Town Council of Jerome, Arizona.

#### **BURTON L. EDELSTEIN, DDS, MPH**

Dr. Edelstein is a Board Certified pediatric dentist and Professor of Dental Medicine and Health Policy & Management at Columbia University where he served as Chair of Population Oral Health in the College of Dental Medicine from 2000-2019. From 1998 to 2020, he was Founding President and Senior Fellow in Public Policy at the Children's Dental Health Project, a DC-based organization that promoted governmental policies and programs to improve children's oral health equity. His experience in private pediatric dental practice, federal government as a US Senate Staffer and Department of Health and Human Services consultant, academe as a researcher, teacher, and administrator, and advocacy provides perspective on current and future oral health care delivery and financing.

#### **CASWELL EVANS, JR., DDS, MPH**

Dr. Caswell Evans Jr. recently retired from his position as the Associate Dean for Prevention and Public Health Sciences at the University of Illinois, Chicago (UIC) College of Dentistry. He also served as the Executive Editor and Project Director for Oral Health in America: A Report of the U.S. Surgeon General. Dr. Evans was previously the Director of Public Health Programs and Services for the Los Angeles County Department of Health Services. Prior to that, he was director of the King County Division of the Seattle-King County Department of Public Health.

Dr. Evans is a member of the National Academy of Medicine, National Academy of Sciences and is currently co-chair of its Global Forum on Innovation in Health Professional Education. He is a past president of the American Public Health Association, the American Association of Public Health Dentistry and the American Board of Dental Public Health. Dr. Evans is President of the Institute of Medicine of Chicago and Chairman of the DentaQuest Foundation's Board. He also serves on the Chicago Board of Health and the board of the Children's Dental Health Project.

#### **ALLAN J. FORMICOLA, DDS, MS**

Dr. Allan Formicola is Dean Emeritus and Professor Emeritus of the Columbia University College of Dental Medicine. He is credited with expanding the school's mission by creating a far-reaching community-based network of care known as the Community DentCare Network. The program has dramatically improved access to oral health care in the underserved communities of northern Manhattan – Harlem, Washington Heights, and Inwood. He headed the Northern Manhattan Community Voices Collaborative, one of the W. K. Kellogg Foundation's 17 national sites. It expanded the DentCare Network to include 35 community-based organizations and all units of the Columbia University Medical Center to improve the general health of the communities.

The accomplishments of this program can be found in "Mobilizing the Community for Better Health (Formicola A and Hernandez-Cordero L. *Mobilizing the Community for Better Health*, Columbia University Press, 2010.). After his 23-year deanship, Dr. Formicola established the Center for Community Health Partnerships, which merged with the Center for Family and Community Medicine at Columbia. Dr. Formicola has served in many national leadership positions, such as President of the American Association of Dental Schools. Among a number of national demonstration projects he operated, Dr. Formicola co-directed (with Dr. Howard Bailit) the Robert Wood Johnson Foundation project entitled *Pipeline, Profession & Practice: Community-Based Dental Education*, which assisted 23 dental schools to establish community-based education programs and to increase their enrollment of underrepresented minority students. Dr. Formicola has published extensively and been the recipient of many honors and awards.

#### **JOHN C. FRACHELLA, DMD**

John Frachella, DMD is a pediatric dentist in Oregon and Maine with 40+ years' experience in the delivery of dental services in public and private settings. For the first 32 years of his career, he was the dental director of a free clinic for indigent children in Bangor, Maine and is recently retired from being the director of Asher Dental Services in Wheeler County, Oregon. He also works in private practices across the country, is on staff at OHSU Dental School and lectures for Lutheran Medical College dental residency programs. Over the past 12 years, Dr. Frachella has been using silver solutions in combination with glass ionomer technology to arrest caries while simultaneously addressing destructive cavitation caused by caries. He sees the minimally invasive, non-aerosol medical management of caries as a new yet historically proven, highly preventive standard of care for the treatment of worldwide populations of children and special needs adults who desperately need restorative and preventive dental services the most.

#### **JAY FRIEDMAN, DDS**

Dr. Jay Friedman has had a significant impact on the oral health of the public. His commitment to public health has spanned seven decades from the 1950s to the present. He pioneered in the development of quality standards for dental care, group practice, and dental insurance. An accomplished clinician, he has been a consultant to a number of state and national organizations. Notable are Dr. Friedman's remarkable contributions in leading the challenge against the prophylactic extraction of third molars, as well as advocating for adding dental therapists to the oral health workforce.

Dr. Friedman earned his Doctor of Dental Surgery degree from Columbia University in 1948. Subsequently, he practiced general dentistry in Farmingdale, New York from 1948-1954, including two years in the U.S. Air Force Dental Corps. In 1955, Dr. Friedman became the director of an innovative group practice dental cooperative in Seattle, Washington, which served as a prelude to his pursuit of a life in public health. He received his MPH in 1962 at the University of Michigan, followed by an NIH Fellowship. Friedman then moved to Los Angeles, California, becoming actively engaged in research, writing, consulting, and clinical practice. In 2012, he received the John W. Knutson Distinguished Service Award in Dental Public Health from the Oral Health Section of the American Public Health Association.

### **SAULO GERALDELI, MS, PhD, DDS**

Dr. Saulo Geraldeli is a graduate of the University of Mogi das Cruzes, Brazil, where he received his DDS degree in 1987. She is currently the Founding Director of the award-winning NDA-HEALTH NOW® Project and architect of the Inter-Professional Student Leaders Colloquium and Summit. Since Deamonte's death, Dr. Harper has

devoted her energies and creative talents to developing, implementing and supporting inter-professional health education programs and community outreach events in cities across America and the world.

Her reputation for innovation and success has merited awards from several foundations including the W.K. Kellogg Foundation, Coca Cola Foundation, Henry Schein Cares Foundation, Aetna Foundation, GE's African American Forum, the Pew Charitable Trusts, the DentaQuest Foundation and many others. She received an Honorary Doctorate from Medgar Evans College in Brooklyn, NY. Dr. Harper lectures and writes extensively on eliminating health disparities; and in 2019, she was lead author of book chapters in *Oral Health in America: Removing the Stain of Disparities*, published by the American Public Health Association. ### **TODD HARTSFIELD, DDS**

### **BRIAN HOLLANDER, DDS, MS**

Dr. Brian Hollander formerly served as the dental director for the Yukon Kuskokwim Health Corporation in Bethel, Alaska, where he worked with his staff to serve remote villages throughout the state. Now living in Anchorage, he continues to serve remote villages as a dentist for Southcentral Foundation, a health care organization that seeks to improve the health and social conditions of Alaska Natives and American Indians.

He co-named SMART fillings and has done much to develop and promote that technique; essentially it is to use SDF to dramatically decrease and in many cases eliminate caries excavation. Dr. Horst has been developing and promoting minimally invasive maximally effective techniques to manage dental caries.

He has been an advocate for DHATs since 2006 when fighting for the AK program, within UW and in the Washington legislature. Dr. Horst has traveled to AK and WA to teach the DHATs in the program and in their alumni group; written letters to many dental boards advocating for RDHs and DHATs/DTs to practice in dentist-free situations such as schools and nursing homes, particularly focusing on and succeeding in preventing blocks to these folks placing SDF, FV, sealants, etc. in these situations.

Dr. Milgrom's current work includes research on the effectiveness of fluoride varnish and iodine in preschoolers, clinical efficacy and safety of silver diamine fluoride in children and older adults, delivery and pay-for-performance systems in dental managed care organizations to increase perinatal and child dental visits and decrease disparities in rural communities, behavioral studies of behavioral interventions to improve dental visiting and diet, and studies of cognitive interventions in pediatric and adult dental fear. Dr. Milgrom is author of 5 books and over 325 scientific articles. Dr. Milgrom received his DDS from the University of California, San Francisco and had a previous position at the National Academy of Sciences, Engineering, and Medicine.

Most recently, he has led strategic planning with the UK Provost's Office, the UK College of Public Health and the COHR for university implementation of a new interdisciplinary Kentucky Oral Health Innovation Initiative (KOHII). From 2011-2017, he served the UK Project Leader for an Appalachian Rural Dental Education Partnership (ARDEP), a major Appalachian Regional Commission (ARC) demonstration project with Morehead State University. and multiple KOHN partners.

Dr. Mullins received a Doctor of Dental Medicine degree (D.M.D.) from the University of Kentucky (1968) and a Master's in Public Health degree (M.P.H.) from the School of Public Health at the University of North Carolina (1970). He is a past department Chair and Academic Dean, holding dental public health, research, and academic leadership positions at UK for 46 years. In 2006, he was inducted into the Kentucky Public Health Hall of Fame. He is also a Past-President of the American Association of Public Health Dentistry (1981-82). In 2014, Dr. Mullins received Distinguished Alumni Awards from the University of Pikeville and the UK

College of Dentistry. In 2015, he received the Lois Baker Exemplary Service Award from the Kentucky Primary Care Association. In 2018, Dr. Mullins received a special Chair's citation from the American Dental Education Association (ADEA), recognizing his career contributions to ADEA's mission. He is a current member of the Community Advisory Committee for the Foundation for Healthy Kentucky and the Executive Board of the Kentucky Primary Care Association.

### **RONALD NAGEL, DDS, MPH**

Dr. Ron Nagel, known for his patience, high standards, and integrity, devoted 22 years to working for the Indian Health Service, promoting oral health and better access to oral health care for American Indians and Alaska Natives. Dr. Nagel initiated the Alaska dental health therapist program and helped make it a reality despite enormous opposition by organized dentistry. He worked tirelessly to improve access to oral health care for a population with oral disease rates of 2.5 times the national average. Dr. Nagel devoted himself to making oral health services available for this neglected population who live in a rural area of 600,000 square miles with no roads, no electricity, no running water, and no dentists.

### **ALEJANDRO NARVÁEZ, DDS**

Dr. Alejandro Narváez has directed Sea Mar's dental services since 1982. He oversees clinical practice and operations for all Sea Mar dental clinics. His philosophy of care is that all people, regardless of income, race, ethnicity, gender, or sexual orientation, deserve the highest quality health care.

Originally from California, Dr. Narváez was raised in a low-income, bilingual/bicultural family where he learned the value of a strong work ethic. In 1977, he earned a Bachelor of Arts degree from Stanford University and completed an independent internship at Moses Lake Community Health Center where he gained a deep appreciation for the mission of community health centers to help underserved populations.

Dr. Narváez earned a Doctor of Dental Surgery degree from the University of Washington in 1982 and completed a course for general practitioners in orthodontics in 1998. He presently practices dentistry in the White Center and South Park clinics, with a focus on children and limited orthodontics.

Throughout his career, Dr. Narváez has devoted time to many worthy causes and professional activities. He has served on the Washington Dental Service Foundation Board of Trustees since 2006 and he participates in Sea Mar activities and other community events focusing on health care.
